_____ (Initial) **This is a month-to-month membership and may be cancelled with a 30-days notice.** To cancel your membership, you must complete & execute the official *Head Quarters, Inc* cancellation form with Head staff, forms can be faxed or emailed 30 days prior to your **final** withdrawal date. All accumulated massages will be forfeited upon cancellation. Failure to pay for two consecutive months terminates your membership agreement and forfeits your massages. There is a twelve month expiration per session, no exceptions. **Cancellations received on the 1st - 15th of the month**-memberships will terminate at the end of that month and automatic withdrawals will stop with that month's payment. **Cancellations received on the 16th - the end of the month**-memberships will terminate at the end of the following month and automatic withdrawals will stop after the following month's payment. **No cancellation required on prepaid memberships.**

_____ (Initial) We understand that life happens and you cannot always give notice if unable to keep an appointment. We do ask our patients to try to give at least 24 hours notice if possible. However, if two consecutive appointments are cancelled without 24 hours notice, you will automatically be charged a \$35.00 missed appointment fee to the card on file the following business day.
